WHEREAS, there is some evidence that local, state, and national regulations may unduly impact the cost of housing; and

WHEREAS, the United States Department of Housing and Urban Development is encouraging active participation in the "Joint Venture for Affordable Housing Program"; and

WHEREAS, the United States Department of Housing and Urban Development, in selecting communities for participation, desires local support in identifying and evaluating the need for certain regulations that may increase cost; and

WHEREAS, The City of San Diego desires to fully participate in the "Joint Venture for Affordable Housing" so as to expand housing opportunities in the community, particularly through the Living Unit Program; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the Mayor and Council of The City of San Diego actively participate in the Living Unit Program for the "Joint Venture for Affordable Housing."
