RESOLUTION NUMBER R- 270585

ADOPTED ON MAR 21 1988

WHEREAS, the State of California, the California Transportation Commission and local jurisdictions are authorized to enter into cooperative agreements for improvements to State highways within cities and counties; and

WHEREAS, congestion on Interstate 5 and 805 in the South Bay is increasing at an alarming rate; and

WHEREAS, expected industrial development on Otay Mesa will place further demands on the existing roadways; and

WHEREAS, extension of State Route 125 from State Route 54 to proposed Interstate 905 would help alleviate traffic congestion in the South Bay; and

WHEREAS, the officially adopted Regional Transportation Plan indicates the need for a freeway to extend State Route 125 from State Route 54 to proposed Interstate 905 because development is rapidly occurring in the State Route 125 Corridor; and

WHEREAS, the recently approved local sales tax for transportation provides construction funding and state law provides authorization for environmental and route location studies for the portion of State Route 125 from State Route 54 to San Miguel Road; and

WHEREAS, the Council has included preliminary engineering studies for State Route 125 in the Proposition A and Capital Outlay (M.O.E.) Expenditures Plan for Fiscal Year 1989; and

WHEREAS, for proper planning, the route location studies should be done for the entire corridor from State Route 54 to Interstate 905 simultaneously; NOW, THEREFORE,

BE IT RESOLVED, that the Council of The City of San Diego approves in principle its support of and participation in the environmental and route adoption study for State Route 125 between Interstate 905 and San Miguel Road.

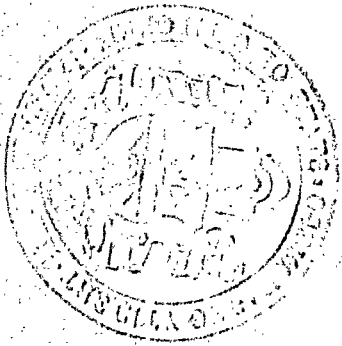
