Kenneth Norton	General Services	\$451.38	Mr. Norton is a Senior Communications Technician with the Communications Division. He suggested the modification of the automatic receiver selector modules of the tone receivers. Actual one year's savings of \$4,029.27 in parts was realized. This is the remainder of his award.
Robert Davis	Utilities	\$160.00	Mr. Davis is an Electronic Technician. He suggested the buildings of a safety railing at the south edge of the roof at sewer pump station #19. Although savings are difficult to identify, this was considered a significant safety improvement.
Sharon Smith	Purchasing	\$ 80.00	Ms. Smith is a Word Processing Operator. She suggested the use of a carbon-treated, two-part form for Minority and Women owned Business Enterprise contacts form used by the Purchasing Department. Although savings are difficult to identify, this was considered a significant operational improvement.
Robert Kruger	Clerks	\$ 80.00	Mr. Kruger is a Community Development Specialist IV with the Property Department, He suggested implementation of a subject index to the Council Agenda which lists subject and proposed action. Although savings are difficult to identify, this was considered a significant operational improvement.
