WHEREAS, Section 6 of the SAVE MISSION BEACH PARK (BELMONT PARK) initiative (Proposition G), was enacted by the voters of the City of San Diego and is effective as of November 4, 1987; and

WHEREAS, supporters of the Giant Dipper, the Belmont Park roller coaster, have requested that the City Council make a determination that under Section 1, Subsection (b) of Proposition G the roller coaster is specifically authorized to recommence commercial operation; and

WHEREAS, on March 10, 1988, the City duly noticed a public hearing for the purpose of receiving testimony and evidence with respect to said application; and

WHEREAS, on March 21, 1988, the City Council conducted a public hearing with respect to said application at which time the City Council received and considered evidence on the matter, both oral and written; and

WHEREAS, at said public hearing testimony and evidence was submitted to the effect that the operation of the coaster is economically feasible and that Section 1, Subsection (b) of Proposition G was intended to and does specifically allow for the rehabilitation and commercial operation of the roller coaster; NOW, THEREFORE,

BE IT RESOLVED, based upon the testimony and evidence submitted at said public hearing, the City Council of The City of San Diego hereby finds that the commercial operation of the roller coaster is economically feasible and that the roller coaster is specifically authorized to recommence commercial operation pursuant to the language contained in Section 1, Subsection (b) of Proposition G.

BE IT FURTHER RESOLVED, that in adopting this resolution the City Council hereby incorporates all of the testimony and documentary evidence submitted at said public hearing as its basis for the above findings.
