

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to offer to purchase said property.

BE IT FURTHER RESOLVED, that the expenditure of not to exceed \$450,000 as payment for said property and related costs from Open Space Park District Bond Fund 79103 is hereby authorized and approved.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to accept the deed to said property without further Council action.
