BE IT FURTHER RESOLVED, that a contingency cost not to exceed \$21,430.50, or 5% of the bid price, for changes as may be necessary during the manufacturing process is hereby provided.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$477,900.15 from CIP No. 33-028 FIRE STATION #41 - MIRA MESA (FBA Fund 79006 - Mira Mesa) for the acquisition of fire apparatus is hereby authorized and authorizing the Auditor and Comptroller, upon advise from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
