ADOPTED ON APR 04 1988

Whereas the City Manager of the City of San Diego has made recommendations based on the facts therein stated in Report No. 88-173 that the Harper Company, a California corporation in the City of San Diego, be declared a non-responsible bidder and therefore ineligible to bid on City work for a period of three years; and

Whereas, Harper Company is not currently performing satisfactorily on City contracts, and

Whereas, Harper Company's deficiencies have resulted in added costs to the City, damage to public and private property and public inconvenience; and

Whereas, Harper Company has consistently submitted incomplete equal opportunity paperwork and exceeded the time limits allotted for performance of jobs awarded to his company; Now, Therefore,

BE IT RESOLVED, by the Council of the City of San Diego, that the Council hereby finds that the Harper Company has failed to perform satisfactorily on City contracts and therefore declares the Harper Company to be a non-responsible bidder and therefore ineligible to bid on City work for a period of three years pursuant to San Diego Municipal Code Section 22.0514.
