Processing Corporation and San Diego Housing Commission, among
others, have, in the past, secured audit services independently;
and

WHEREAS, this agreement will reflect a consolidated effort to retain, at the lowest cost, a qualified firm to provide The City of San Diego and the above legal entities with audit services; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with DELOITTE, HASKINS & SELLS/ARMANDO MARTINEZ & COMPANY, to conduct the City's audits for fiscal year 1988-1992, under the terms and conditions set forth in the agreement, on file in the office of the City Clerk as Document No. RR-270647.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$50,000 from General Fund Nondepartmental Expenditures (601) and \$20,000 from Water Utilities (700) [\$10,000 from Fund 41506 and \$10,000 from Fund 41500] is hereby authorized, solely and exclusively for the purpose of providing funds for the above project.
