ADOPTED ON APRIL 4, 1988


BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager is hereby authorized to negotiate exclusively with Casa Familiar to plan the social services programs at the San Ysidro Community Activity Center as operators.

BE IT FURTHER RESOLVED, that the City Manager is directed to prepare for review by PF&R Committee an operating plan that is consistent with the existing operation of the center plus any additions.

BE IT FURTHER RESOLVED, that the City Manager directs the Park and Recreation Department to continue to run the San Ysidro Boys Club and Community Facility.

BE IT FURTHER RESOLVED, that the City Manager is directed to work with the United Way for possible funding for the Center.
