

RESOLUTION NUMBER R- 270690


ADOPTED ON APR 11 1988

BE IT RESOLVED, by the Council of The City of San Diego that the low bids of 1. JOHN C. HENBERGER CO. and 2. PERVO PAINT CO. DBA COLORAMA PAINT, meeting specifications, are hereby accepted and the City Manager is hereby authorized to execute contracts for the purchase of HOT INSTANT DRY WATER-BORNE TRAFFIC PAINT (YELLOW & WHITE) as may be required for a period of two (2) years beginning April 1, 1988 through March 31, 1990, with options to renew contracts for up to two (2) additional one (1) year periods. Prices after the first contract year to be increased or decreased every six (6) months in an amount directly proportional to the Producer Price Index published by the U.S. Department of Labor, Bureau of Labor Statistics, for the groupings "Prepared Paint" and "Paint Materials", using the average of these two indices; and with the option to cancel at the end of each fiscal year if the City fails to provide funding for the purchase of traffic paint, as follows:

- (1) JOHN C. HENBERGER CO. for Item 1, Yellow, Hot, Instant Dry Traffic Paint, at a cost of \$5.21 per gallon, for a total estimated cost of \$125,821.50; terms net 30 days, plus sales tax.
- (2) PERVO PAINT CO. DBA COLORAMA PAINT for Item 2, White, Hot, Instant Dry Traffic Paint, at a cost of \$4.86 per gallon, for a total estimated cost of \$58,684.50; terms 2% 30 days, plus sales tax, plus a tote charge of fair market value, not to exceed \$400.00, if tote not available for return.

BE IT FURTHER RESOLVED, that the Purchasing Agent is hereby authorized to obtain this material on an emergency basis in the event either of the successful contractors is unable to deliver paint meeting these specifications in the stated delivery time, in accordance with the emergency price clause of the bid proposal.
