BE IT RESOLVED, by the Council of the City of San Diego that all bids theretofore received on December 23, 1987, pursuant to publication of notice calling for bids on CONSTRUCTION OF RANCHO BERNARDO MEDIANS IMPROVEMENTS are hereby rejected.

BE IT FURTHER RESOLVED, that the revised plans and specifications for the furnishing of all labor, material, tools, equipment, transportation and other expense necessary or incidental for CONSTRUCTION OF RANCHO BERNARDO MEDIANS IMPROVEMENTS filed in the office of the City Clerk of the City of San Diego, California, on APR 11 1988, and bearing official Document No. W.O. 119560, be and the same are hereby approved.

BE IT FURTHER RESOLVED, that the Purchasing Agent of the City of San Diego be, and he is hereby authorized and directed to proceed to publish in accordance with law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for CONSTRUCTION OF RANCHO BERNARDO MEDIANS IMPROVEMENTS accordance with the specifications.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$81,950 from CIP No. 29-549 RANCHO BERNARDO MEDIANS previously authorized by Resolution No. 268797, adopted on July 13, 1987, is hereby reauthorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.

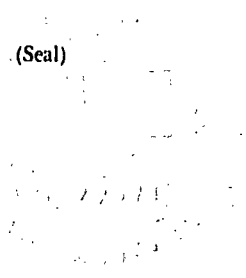
