APPROVING MAP OF COSTA VERDE.

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That said Council hereby finds that certain map surveyed by Richard Eugene Gaddy, Licensed Land Surveyor, entitled "COSTA VERDE being a subdivision of portions of Parcels 1 through 6 inclusive of Parcel Map No. 14708 in the City of San Diego, County of San Diego, State of California, according to map thereof filed in the office of the County Recorder of San Diego County, together with Costa Verde Boulevard, Esplanade Court, Plaza De Palmas and portions of Nobel Drive, Regents Road, Genesee Avenue and La Jolla Village Drive as dedicated to public use," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following: a portion of Nobel Drive and said portion of a public street is hereby declared to be a portion of a public street and dedicated to the public use, as dedicated and shown on said map and subject to the conditions set forth thereon.


That said Council hereby accepts on behalf of The City of San Diego, any and all abutters' rights of access in and to La Jolla Village Drive, adjacent and contiguous to Lots 1 and 12, all as shown on the map within the subdivision.

That said Council hereby accepts on behalf of The City of San Diego, the building restricted easements over, upon or across all of Lot 9, as granted and shown on the map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map, that said portion of a public street is accepted on behalf of the public as heretofore stated; that those certain abutters' rights of access, as well as the building restricted easements, all as granted and shown on the map within this subdivision are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
