BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That the acceptance by the City Manager of that deed of SYNOD OF SOUTHERN CALIFORNIA, executed in favor of The City of San Diego, bearing date of February 23, 1988, conveying to said City an easement for the installation and maintenance of two cypress trees in portions of Lot 11, Block 59, Linda Vista Unit No. 4, Map No. 3256, as more particularly described in said deed, a copy of which is on file in the office of the City Clerk as Document No. RR-270695-1, is hereby approved.

2. That the Mayor and City Clerk of said City be, and they are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a quitclaim deed, a copy of which is on file in the office of the City Clerk as Document No. RR-270695-2 quitclaiming to SYNOD OF SOUTHERN CALIFORNIA, all of the City's right, title and interest in the four easements for cypress trees in Lot 11, Block 59, Linda Vista Unit 4, as more particularly described in the quitclaim deed.

3. That the City Clerk is hereby authorized and directed to deliver both deeds, and a certified copy of this resolution to the Property Director for further handling.
