WHEREAS, on February 29, 1988, the San Diego Public Library was notified that an Artist-in-Libraries grant application submitted in conjunction with local artist Jesus Papoleto Melendez has been approved by the California State Library; and

WHEREAS, federal funds from the Library Services and Construction Act, in the amount of \$4,000 has been awarded to the San Diego Public Library; and


WHEREAS, the grant will fund a four-month Artist-in-Residence Program beginning May 1988 through August 1988 at the Valencia Park Branch Library located at 101 50th Street; and

WHEREAS, the goal of the program is to continue to expose community youth to artists and art materials that have not previously been a part of their lives; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to accept, for and on behalf of said City, grant funds in the amount of \$4,000, from the California State Library System Library Services and Construction Act, to implement the San Diego Public Library "Artist in Libraries" project.

BE IT FURTHER RESOLVED, that the City Manager or his designated representative is hereby authorized to perform all necessary acts to administer the funds.
