WHEREAS, approval of the City's application is expected in the second quarter of FY 1988; and


WHEREAS, Requests for Proposals ("RFP") were published in August, 1987, to find an operator for the San Diego FTZ; and

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be authorized to enter into exclusive negotiations with Cal Cartage Enterprises for the operation of the San Diego Foreign Trade Zone.
