WHEREAS, on July 27, 1987, the City Council authorized the City Manager to contract for services for a Hepatitis "B" vaccination program for Fire Department uniformed personnel; and

WHEREAS, through the competitive bid process, five proposals were received whereby Industrial Medical Group, Inc. was selected to provide the education and vaccination programs; NOW,

THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That an agreement with Industrial Medical Group, Inc. to provide a Hepatitis "B" vaccination program to Fire Department uniformed personnel be and is hereby awarded.



That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with Industrial Medical Group, Inc., to provide a Hepatitis "B" vaccination program to Fire Department uniformed personnel beginning March 1, 1988 through June 30, 1990, under the terms and conditions set forth in the agreement, on file in the office of the City Clerk, as Document No. RR- 270716 .

3. That the City Auditor and Comptroller be and he is hereby authorized to expend an amount not to exceed \$26,000 from the

Risk Management Department (6029), Fund 60029 and \$26,000 from
the Fire Department (120), Fund 100, for the above program.
