WHEREAS, a \$20,000 contribution, \$10,000 from the Weingart Foundation and \$10,000 from the Price Charitable Remainder Trust was also donated to be used for restoration and operation of the San Ysidro Boys Club; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

- 1. That the expenditure of an amount not to exceed \$10,000 from CIP No. 58-007.0, entitled "Annual Allocation Overhead and Other City Costs for Federal Grant Projects" [\$10,000 from Capital Outlay Fund 30245] is hereby authorized for ineligible CDBG overhead costs.
- 2. That the expenditure of an amount not to exceed \$172,000 from CIP No. 37-183, entitled "San Ysidro Boys Club" [\$75,000 from CDBG Fund 18519 and \$97,000 from CDBG Fund 18520] is hereby authorized for the renovation of San Ysidro Boys Club.
