RESOLUTION NUMBER R- 270721

ADOPTED ON APR 11 1988

WHEREAS, the Immigration Reform and Control Act (IRCA), P.L. 99-803, provides for a legalization program for undocumented persons who have resided in this country since January, 1982 and meet certain other criteria; and

WHEREAS, only 1.3 million of the 3.9 million persons estimated to be eligible by the Immigration and Naturalization Service have submitted applications since the IRCA was implemented in May, 1987; and

WHEREAS, the amnesty period for the legalization program ends on May 4, 1988; and

WHEREAS, concerns exist relating to the implementation of the IRCA, such as delays in initiating the public education campaign, changing and conflicting regulations and administrative delays in processing applications, all which may have led to a low participation rate; and

WHEREAS, H.R. 3816 (Schumer) and S. 2015 (Kennedy) provide an extension of the amnesty period for one year to May 4, 1989; and

WHEREAS, Intergovernmental Relations Report No. 88-8, dated April 6, 1988 discusses the law, existing and proposed, and presents recommendations to support the proposed law; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the recommendation to support H.R. 3816 (Schumer) and S. 2015

(Kennedy), as set forth in Intergovernmental Relations Report No. 88-8, be and the same is hereby adopted.
