

RESOLUTION NUMBER R- 270730

ADOPTED ON APR 12 1988

WHEREAS, on October 22, 1987, the Planning Commission of The City of San Diego held a public hearing to consider the proposed amendment of the MIRA MESA COMMUNITY PLAN (NO. 84-0667) for the purpose of redesignating a 13.4-acre site from cemetery to manufacturing industrial to allow industrial uses to be developed south of Mesa Rim Road and adjacent to the existing Lusk Mira Mesa Business Park East in the Mira Mesa planning area; and

WHEREAS, following public testimony and Planning Commission review of said plan amendment, the Planning Commission found the amendment was not compatible with the goals and objectives of the MIRA MESA COMMUNITY PLAN; and

WHEREAS, on January 5, 1988, the Council of The City of San Diego held a public hearing to consider the proposed amendment to the MIRA MESA COMMUNITY PLAN (NO. 84-0667) and continued the public hearing until April 12, 1988, directing the applicant to redesign the project pursuant to the Planning Group and Planning Department recommendations; and


WHEREAS, on April 12, 1988, the Council of The City of San Diego held a public hearing to consider the proposed amendment of the MIRA MESA COMMUNITY PLAN (NO. 84-0667) which had been redesigned per City Council direction for the purpose of redesignating a 13.4-acre site from cemetery to restricted industrial (7.5 acres) and open space (5.9 acres) to allow

industrial uses to be developed south of Mesa Rim Road adjacent to the existing Lusk Mira Mesa Business Park East in the Mira Mesa planning area; and

WHEREAS, the Council of The City of San Diego having considered all maps, exhibits, written documents and materials in this matter, having heard all oral presentations given at the public hearing, and being fully advised concerning the same; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this City Council hereby approves the proposed amendment of the MIRA MESA COMMUNITY PLAN, a copy of which is on file in the office of the City Clerk as Document No. RR- 270730.
