BE IT RESOLVED, by the Council of The City of San Diego that the low bid of HORIZON HIGH REACH & EQUIPMENT CO., meeting specifications, is hereby accepted and the City Manager is hereby authorized to execute a contract for the RENTAL OF ONE LIFT TRUCK WITH 39 FT. AERIAL TOWER AND TWO VAN MOUNTED 33 FT. AERIAL TOWERS as may be required for a period of one (1) year beginning June 1, 1988 through May 31, 1989, one (1) each Lift Truck with 39 ft. Aerial Tower at a cost of \$1,150.00 per month and two (2) each Van Mounted Aerial Towers (Alternate B) with 33 ft. working height, with PTO (fan belt-truck power) at a cost of \$1,000.00 per month each, for a total estimated annual cost of \$37,800.00; terms net 30 days, plus sales tax, plus delivery and return charges of \$50.00 each for each piece of equipment; with options to renew contract for thirty-six (36) additional months on a month-to-month basis and options to buy at the end of each twelve (12) month rental period.
