RESOLUTION NUMBER R- 270757

APPROVING MAP OF N.C.W. NEIGHBORHOOD 6,
UNIT 1.

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That said Council hereby finds that certain map surveyed by Douglas C. Paul, Registered Civil Engineer, entitled "N.C.W. NEIGHBORHOOD 6, UNIT 1 being a subdivision of portions of Lot 2 (the Southwest Quarter of the Northwest Quarter) of Section 19, Township 14 South, Range 3 West, San Bernardino Meridian and a portion of the Southeast Quarter of the Northeast Quarter of Section 24, Township 14 South, Range 4 West, San Bernardino Meridian, in the City of San Diego, County of San Diego, State of California, together with those portions of El Camino Real, High Bluff Drive, Carmel View Road, and a pedestrian and non-motor vehicular right of way all as dedicated to public use," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted.

That said Council hereby accepts on behalf of The City of San Diego, any and all abutters' rights of access in and to El Camino Real, adjacent and contiguous to Parcels "A" and "B"; in and to High Bluff Drive, adjacent and contiguous to Parcel "A," all as shown on the map within the subdivision.


That said Council hereby accepts on behalf of The City of San Diego, the easements with the right of ingress and egress of emergency vehicles and for the construction and maintenance of general utility facilities, as granted and shown on the map within the subdivision.

That said Council hereby accepts on behalf of The City of San Diego, the building restricted easements over, upon or across all of Lots 1, 2, 3, 4 and Parcels "A," "B," "C," "D," "E" and "G," as granted and shown on the map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that those certain abutters' rights of access, together with the easements with the right of ingress and egress of emergency vehicles and for the construction and maintenance of general utility facilities, as well as the building restricted easements, all as granted and shown on the map within this subdivision are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
