Lori Vereker	Utilities	\$407.53	Ms. Vereker is a Marine Biologist III with the Metro Division. She suggested the use of a 13 cubic foot freezer as a dessicator for storing microbiological media. The actual savings is \$4,075.25. This is her full award.
Jacqueline Clayton	Building Inspection	\$315.00	Ms. Clayton is a Building Inspector. She suggested the use of a form letter to encourage owners and contractors to obtain inspections on expired permits under the old permit system. The estimated first year's savings is \$6,300. This is a partial award pending a 12-month review.
Billie Johnson	Utilities	\$ 90.00	Mr. Johnson is an Electrician. He suggested the posting of signs near the waste water treatment facility entrance warning that construction is underway. Although savings are difficult to identify, this suggestion was considered to be a significant operational improvement.
James O'Neill	Police	\$ 90.00	Mr. O'Neill is a Detective. He suggested having Northeastern Division police vehicles washed at the Shell Station in Penasquitos. Although savings are difficult to identify, this was considered to be a significant operational improvement.
