
ADOPTED ON APR 18 1988

SAN DIEGO SEASIDE COMPANY towards the completion of an environmental review for the restoration and operation of the Belmont Park Roller Coaster.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to commence negotiations with SAN DIEGO SEASIDE COMPANY, for a lease pursuant to which the restoration and operation of the roller coaster will occur, and to report to the Public Facilities and Recreation Committee in approximately four weeks with the details of the proposed lease.
