RESOLUTION NUMBER R- 270778

ADOPTED ON APR 18 1988

WHEREAS, on May 15, 1979, the California Coastal Commission certified the Otay Mesa/Nestor segment Local Coastal Program ("LCP") Land Use Plan; and

WHEREAS, on August 27, 1982, the California Coastal Commission certified the Border Highlands segment LCP Land Use Plan; and

WHEREAS, on February 23, 1983, the California Coastal Commission certified the Barrio Logan/Harbor 101 segment LCP Land Use Plan; and

WHEREAS, on April 26, 1983, the California Coastal Commission certified the La Jolla/La Jolla Shores segment LCP Land Use Plan; and

WHEREAS, on November 15, 1984, the California Coastal Commission certified the resubmitted Tijuana River Valley segment LCP Land Use Plan; and

WHEREAS, on November 15, 1984, the California Coastal Commission certified the Mission Beach segment LCP Land Use Plan; and

WHEREAS, on August 27, 1985, the California Coastal Commission certified the resubmitted Pacific Beach, Ocean Beach, and Peninsula segment LCP Land Use Plans; and

WHEREAS, on January 13, 1988, the California Coastal Commission certified the resubmitted North City and Centre City/Pacific Highway Corridor segment LCP Land Use Plans; and

WHEREAS, the implementing regulations of the California Coastal Commission require the City Council (as the local governing body) to acknowledge receipt of the Coastal Commission's resolution of certification of the above land use plan segments including any terms or modifications which may have been required for certification, and to accept and agree to such terms and modifications by taking whatever formal action is required to satisfy such terms and modifications; and

WHEREAS, said regulations also require the acknowledgement of the local governing body to occur within six (6) months of the Coastal Commission's certification of the LCP Land Use Plan; and

WHEREAS, due to the complexity of the City's LCP and for reasons of convenience, the City Council has not formally acknowledged the Coastal Commission's certification of the above segment LCP Land Use Plans; and

WHEREAS, the six (6) month period to acknowledge certification of the City's LCP Land Use Plan has expired for all land use plan segments except the North City and Centre City/Pacific Highway Corridor segment LCP Land Use Plans; and

WHEREAS, it is in the interest of the City to consolidate the certification date of all LCP segment Land Use Plans and to formally comply with said regulations; NOW, THEREFORE,


BE IT RESOLVED, by the City Council of The City of San Diego, that it hereby authorizes the Planning Director to resubmit the Otay Mesa/Nestor, Border Highlands, Barrio Logan/Harbor 101, La Jolla/La Jolla Shores, Tijuana River Valley, Mission Beach, Pacific Beach, Ocean Beach and Peninsula segment LCP Land Use Plans to the Coastal Commission.

BE IT FURTHER RESOLVED, that subject to, and in anticipation of, the Coastal Commission's action to certify the above LCP Land Use Plan segments "as submitted", the City Council accepts the Coastal Commission's certification of the Otay Mesa/Nestor Border Highlands, Barrio Logan/Harbor 101, La Jolla/La Jolla Shores, Tijuana River Valley, Mission Beach, Pacific Beach, Ocean Beach and Peninsula segment LCP Land Use Plans.

BE IT FURTHER RESOLVED, that the City Council of The City of San Diego accepts the Coastal Commission's action of January 13, 1988, to certify the amended North City and Centre City Pacific Highway Corridor segment LCP Land Use Plans.
