
ADOPTED ON APR 18 1988

BE IT RESOLVED, by the Council of The City of San Diego, that the request of MISSION PACIFIC ASSOCIATES for an extension of its lease option from April 18, 1988, to June 18, 1988, at an option consideration rate of \$90,000 per month, or \$3,000 per day, on a nonrefundable, nonlease payment credit basis, is hereby approved.

BE IT FURTHER RESOLVED, that in the event the option is not exercised on or before June 18, 1988, city staff is hereby directed to initiate a study to examine the feasibility of alternative uses for the subject property.
