



BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager is hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a 5-year lease agreement with SAN DIEGO CHAPTER 14, EXPERIMENTAL AIRCRAFT ASSOCIATION, for the use of 40,000 square feet of vacant land at Brown Field, with an initial annual rent of \$3,996, under the terms and conditions set forth in that lease agreement on file in the office of the City Clerk as Document No. RR-270797.
