
ADOPTED ON APR 25 1988

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with HOWARD NEEDLES TAMMEN & BERGENDOFF (HNTB) for services related to the completion of the Route 15 Cover and Planning Study, under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. RR- 270802.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$20,000, \$13,500 of which will come from 1984 CDBG funds allocated to the Mid-City Revitalization Program and \$6,500 of which will come from 1986 CDBG funds allocated to the Mid-City Program, is hereby authorized, solely and exclusively for the purpose of providing funds for the above project.
