BE IT FURTHER RESOLVED, that the Capital Improvements Program of Sewage Utility Revenue Fund (41506) is hereby amended to add the project, Mission Bay Sewage Interceptor System, CIP No. 46-158.0.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer an amount not to exceed \$238,800 within the Sewage Utility Revenue Fund (41506) from Unallocated Reserve (70697) to the Wastewater Construction Engineering Program (70892), Mission Bay Sewage Interceptor System, (CIP No. 46-158.0).

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$192,461 from Sewage Utility Revenue Fund Mission Bay

Sewage Interceptor System, CIP No. 46-158.0, is hereby authorized, solely and exclusively for the purpose of providing funds for the above project.
