BE IT RESOLVED, by the Council of The City of San Diego that the low bid of BURNS & SONS, meeting specifications, is hereby accepted and the City Manager is hereby authorized to execute a contract for REMOVAL & DISPOSAL OF APPROXIMATELY 80,000 CU. YD. OF SLUDGE FROM FIESTA ISLAND as may be required for a period of one (1) year beginning April 1, 1988 through March 31, 1989, at a cost of \$24.95 per cu. yd. for Alternate II (vendor to mix wet and dry sludge) for a total estimated cost of \$1,996,000.00; terms 1% 10 days, with an option to renew contract for an additional one (1) year period with a price increase not to exceed 10% of bid price.

BE IT FURTHER RESOLVED, that in the event the primary contractor is unable to perform successfully, contingency contracts are hereby authorized, as follows:

- (1) E. T. TECHNOLOGIES, INC. for Alternate I, Item 1 at a cost of \$22.94 per cu. yd. and Item 2 at a cost of \$35.91 per cu. yd.
- (2) CHINO-CORONA FARMS, INC. for Alternate II at a cost of \$26.25 per cu. yd., providing all necessary approvals, including approvals from Orange County Health Department are obtained.
