
BE IT RESOLVED, by the Council of The City of San Diego, that the acceptance by the City Manager of a grant deed of MARTIN GLEICH and ENID GLEICH, executed in favor of The City of San Diego, bearing date of December 10, 1987, a copy of which deed is on file in the Office of the City Clerk as Document No.

RR- 270810, granting to said City a portion of Lots 40 and 41 of Rancho Mission of San Diego, for open space purposes, with a reversion by Martin and Enid Gleich to repurchase the property if said property is no longer designated for open space and park and recreation purposes, as more particularly described in said deed, be, and the same is hereby approved.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to accept, for and on behalf of The City of San Diego, the offer of generous donations by Martin and Enid Gleich of \$30,000 each, annually for five successive years, to both the City Library and the Park and Recreation Departments, totaling \$300,000, is hereby authorized and approved.

BE IT FURTHER RESOLVED, that the City Clerk shall cause the deed and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.

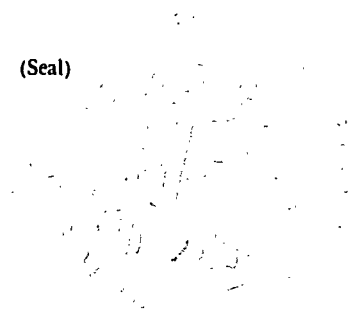
