RESOLUTION NUMBER R- 270813

ADOPTED ON APR 25 1988

WHEREAS, the United States Olympic Training Center Site Ad Hoc Task Force ("Task Force") has been established by the San Diego City Council; and

WHEREAS, the Task Force seeks designation of San Diego by the United States Olympic Committee (USOC) as the exclusive year-round Olympic training site west of the Rocky Mountains; and

WHEREAS, the Site Selection Committee of the United States Olympic Committee has recommended that San Diego be so designated; and

WHEREAS, development of such a facility in San Diego will help the USOC train and develop athletes to represent the United States in international competitions; and


WHEREAS, the presence of these athletes in our community will provide positive role models for the youth of our region; and

WHEREAS, such a facility will provide economic benefits to the people of our region; and

WHEREAS, such facilities will be available to local athletic groups in coordination with the USOC; NOW, THEREFORE,

BE IT RESOLVED, that the Council of The City of San Diego urges the United States Olympic Committee to locate an Olympic training facility in San Diego and pledges its full support and cooperation in locating and developing such a facility.
