RESOLUTION NUMBER R- 270822

ADOPTED ON MAY 02 1988

BE IT RESOLVED, by the Council of The City of San Diego that the low bid of VAN WATERS & ROGERS, INC., meeting specifications, is hereby accepted and the City Manager is hereby authorized to execute a contract for furnishing LIQUID CAUSTIC SODA as may be required for a period of one (1) year beginning July 1, 1988 through June 30, 1989, at a cost of \$275.40 per ton, with an escalation during the contract year not to exceed 10% of bid price, for a total estimated cost of \$363,500.00; terms net 30 days, plus applicable sales tax; with an option to renew contract for an additional one (1) year period, with a price escalation not to exceed 25% of bid price.

BE IT FURTHER RESOLVED, that the Purchasing Agent is hereby authorized to purchase liquid caustic soda on an emergency basis in the event the contract vendor fails to deliver caustic soda on any occasion, from Western States Chemical Supply Corp. or Stauffer Chemical Company per prices on file in the Purchasing Department or, if supply of caustic soda becomes very tight, on the open market.
