- 1. That the City Manager is hereby authorized to initiate proceedings for the formation of said Landscape and Lighting Maintenance District pursuant to the Landscape and Lighting Act of 1972 (Sections 22.500, et seq., Streets and Highways Code) and the San Diego Maintenance District Procedural Ordinance of 1975 (Sections 65.0201, et seq., San Diego Municipal Code), said district shall be known and designated as the LA JOLLA SHORES LANDSCAPE MAINTENANCE DISTRICT.
- 2. That the district will be for maintenance of landscaping only and the district proposes no construction of facilities at this time. That the district proposes to install and maintain landscaping along major streets and other key areas within the district.
 - 3. Pursuant to the Landscape and Lighting Act of 1972 (section 22.500 et seq. of the Street and Highways Code) and the San Diego Maintenance District Procedural Ordinance of 1975 (section 65.0201 et seq. of the San Diego Municipal Code), the City Engineer is hereby ordered to prepare and file a written report on the "La Jolla Shores Landscape Maintenance District."
