RESOLUTION NUMBER R- 270880

ADOPTED ON MAY 3 1988

WHEREAS, the provisions of Council Policy No. 600-15 require that a noticed public hearing be conducted before the City Council prior to the vacation of certain City streets; and

WHEREAS, the vacation of a portion of Britain Street north of Jamacha Road has been initiated by the submission of a tentative subdivision map; and

WHEREAS, Section 66499.20½ of the California Government Code provides that the filing of a final subdivision map shall constitute abandonment of all streets and easements not shown on said map; and

WHEREAS, the proposed subdivision of Highland Hills (TM 87-0624) contains a portion of Britain Street to be superseded by relocation and is no longer required for street purposes; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the portion of Britain Street north of Jamacha Road, all within the Highland Hills Subdivision (TM 87-0624) boundaries, as more particularly shown on the attached Exhibit "A" on file in the office of the City Clerk as Document No. RR- 270880-1, which is by this reference incorporated herein and made a part hereof, be and the same is hereby ordered vacated as provided under Section 66499.20½ of the California Government Code.

2. That the resolution shall not become effective unless and until the final subdivision map for the Highland Hills Subdivision (TM 87-0624) has been approved by Council action. In the event that the final map is not approved within six (6) years of the adoption of this resolution, this resolution shall become void and be of no further force or effect.

3. That the City Engineer shall advise the City Clerk of the approval of the aforementioned subdivision map, and that the City Clerk shall then cause a certified copy of this resolution, with Exhibit "A", attested by him under seal, to be recorded in the office of the County Recorder.
