RESOLUTION NUMBER R- 270883

ADOPTED ON MAY 9 1988

WHEREAS, San Diego's small businesses provide this city, state, and nation with a competitive edge in technological innovation, since small firms provide the majority of new innovations; and

WHEREAS, the spirit of entrepreneurship, fostered by small businesses, is leading economic productivity in our country, with San Diego being realized as the "Entrepreneurial Heartbeat of America"; and

WHEREAS, small businesses provide an avenue of opportunity for women and minorities, and more women and minorities are turning to small business for their realization and participation in the American dream; and



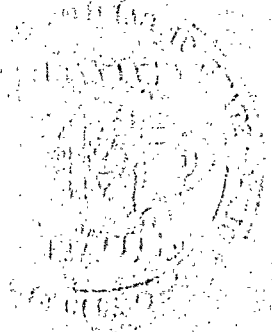
