BE IT RESOLVED, by the Council of the City of San Diego that all bids theretofore received on June 30, 1987, pursuant to publication of notice calling for bids on RENOVATION WORK FOR THE NEIGHBORHOOD OUTREACH PROGRAM are hereby rejected.

BE IT FURTHER RESOLVED, that the revised plans and specifications for the furnishing of all labor, material, tools, equipment, transportation and other expense necessary or incidental for RENOVATION WORK FOR THE NEIGHBORHOOD OUTREACH PROGRAM filed in the office of the City Clerk of the City of San Diego, California, on MAY 91988, and bearing official Document No. W. O. 119873, be and the same are hereby approved.

BE IT FURTHER RESOLVED, that the Purchasing Agent of the City of San Diego be, and he is hereby authorized and directed to proceed to publish in accordance with law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for RENOVATION WORK FOR THE NEIGHBORHOOD OUTREACH PROGRAM in accordance with the specifications.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized and empowered to execute, for and on behalf of said City, a First Amendment to the Agreement with San Diego Youth and Community Service, Inc., a non-profit corporation, filed in the office of the City Clerk as Document No. RR-266530 on September 8, 1986, pursuant to the terms and conditions of the First Amendment on file as Document No. RR-270889, increasing the maximum sum allocated by \$65,000 to better accommodate the handicapped and provide adequate heating and air conditioning systems.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer \$65,000 from Program Income Fund 18502 to Neighborhood Outreach Fund 18522, Dept. 5862, Org. 6207.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$65,000 from Dept. 5862, Org. 6207 to supplement funds previously authorized by Resolution No. 268385, adopted on May 26, 1987, is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
