1. Sunwest Properties, a limited partnership, IS HEREBY DECLARED TO BE IN DEFAULT of the terms and conditions of the Agreement filed in the office of the City Clerk on February 27, 1980, as Document No. RR-251261, and the amended Agreement filed in the office of the City Clerk on March 28, 1983, as Document No. RR-258144, relating to the improvement of Westwood Unit No. 16.

- 2. The City Attorney shall cause notice of this declaration of default to be given to Sunwest Properties, a limited partnership, and to Pacific Insurance Agency. The City Attorney is authorized to take all appropriate measures to recover from Sunwest Properties, a limited partnership, and Pacific Insurance Agency, all costs associated with the completion of the subdivision improvements, as provided by the Agreement and Performance Bond No. 05022.
- 3. The City Manager is authorized to complete, or cause to be completed, said public work and improvements in accordance with the terms of the Agreement.
