Department and the City Attorney's office, it is estimated that
an additional \$300,000 will be needed for the remainder of the
fiscal year for the settlement of claims under \$20,000 and
associated litigation costs; and

WHEREAS, it is therefore requested that up to \$300,000 be authorized for expenditure from the Public Liability Reserve Fund (81140) which has been established for this purpose; and

WHEREAS, if any unexpended funds remain in the operating fund at the end of the fiscal year, then these funds will be returned to the reserve for future needs; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the Auditor and Comptroller be and he is hereby authorized to expend the sum of up to \$300,000 from the Public Liability Reserve Fund (81140) for payment of claims and litigation for the remainder of Fiscal Year 1988.
