RESOLUTION NUMBER R- 270919

ADOPTED ON MAY 9 1988

WHEREAS, the California State Games, sponsored by the Non-Profit California State Game Association, are to be held in San Diego on July 14 through 17, 1988; and

WHEREAS, these games are currently held in thirty-five states, having begun in New York in 1977 with the Empire State Games; and

WHEREAS, these games are supported by the United States Olympic Committee, the President's Council on Physical Fitness, the National Fitness Foundation and the National Congress of State Games; and

WHEREAS, these games include a broad variety of competitive sports including: badminton, baseball, basketball, bowling, cycling, diving, gymnastics, roller skating, soccer, team handball, tennis, track and field, and water polo; and

WHEREAS, approximately 5,000 athletes in San Diego and 350,000 athletes statewide participate in these games; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and directed to provide to the California State Game Association, at no cost, the use of the Federal Building in Balboa Park, for the badminton competition phase of the California State Games.

BE IT FURTHER RESOLVED, that this Council, on behalf of the people of San Diego, does hereby extend to the athletes and sponsors its wish for a very successful event.
