RESOLUTION NUMBER R- 270926

ADOPTED ON MAY 9 1988

WHEREAS, on April 20, 1988, the Escondido City Council, acting as lead agency pursuant to CEQA, certified that Environmental Impact Report (EIR) No. ER 87-84 for the Lomas del Lago Specific Plan had been prepared pursuant to CEQA and that said EIR had been reviewed and considered and that the attached Findings and Statement of Overriding Considerations were adopted; and

WHEREAS, the City of San Diego is a responsible agency, pursuant to CEQA in regards to approving lease agreements for City of San Diego land to be used for the proposed golf course; NOW, THEREFORE,


BE IT RESOLVED, by the Council of the City of San Diego as follows:

1. That environmental effects of the Lomas del Lago Specific Plan, as shown in EIR No. ER 87-84 dated April 20, 1988, have been considered by this Council pursuant to Section 15096(f) of the State CEQA Guidelines;

2. That pursuant to Sections 15091(a)(2) and 15096(h) of the State CEQA Guidelines such changes or alterations as addressed by this EIR are within the responsibility and jurisdiction of the City of Escondido and not the City of San Diego; and

3. That pursuant to Sections 15093 and 15096(h) of the State CEQA Guidelines the City of San Diego adopts the attached Statement of Overriding Considerations.

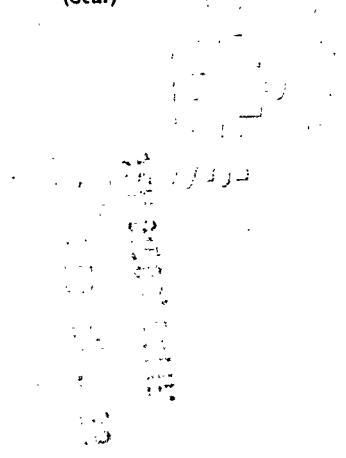
