ADOPTED ON MAY 9 1988

BE IT RESOLVED, by the Council of The City of San Diego, that upon the effective date of the adoption of Ordinance No. O-17054 (New Series), the moratorium on the issuance of jitney permits imposed by Resolution No. R-268429 is rescinded and Council Policy 500-7 is repealed.

BE IT FURTHER RESOLVED, that the City Clerk and the City Manager, as appropriate, shall take the necessary administrative action to accomplish the foregoing.

BE IT FURTHER RESOLVED, that the City Manager is authorized upon the effective date of adoption of Ordinance No. O-17054 (New Series) to establish fifteen (15) minute jitney passenger loading zones at the following locations:


- a) Southeast corner of Broadway at First Avenue;
- b) Southeast corner on First Avenue at Broadway;
- c) Southwest corner on Second Avenue at Broadway;
- d) Northeast corner on Broadway at India Street;
- e) North side of Broadway between Second and Third Avenues;
- f) On Lytton Street east of Naval Training Center Gate No.

1;

- g) On Northbound Harbor Drive at 32nd Street.
