RESOLUTION OF THE COUNCIL OF THE CITY OF SAN
DIEGO ORDERING REORGANIZATION, "SCRIPPS
MIRAMAR RANCH ANNEXATION."

WHEREAS, pursuant to the Cortese/Knox Reorganization Act of 1985, commencing with Section 56700 of the Government Code, preliminary proceedings for annexation to The City of San Diego designated as the "Scripps Miramar Ranch Annexation" were initiated by The City of San Diego by Resolution No. R-268716, pursuant to Title 5, Division 3, commencing with Section 56000 of the Government Code; and

WHEREAS, the executive officer of the Local Agency Formation Commission has filed a report relative to said proposed annexation, which report has been reviewed and considered by the Local Agency Formation Commission; and

WHEREAS, on March 7, 1988, the Local Agency Formation Commission by Resolution No. CA87-9 (attached hereto as Exhibit 1), and thereby approved the proposed annexation and authorized the Council of The City of San Diego to initiate and conduct proceedings for the proposed annexation in compliance with Resolution No. CA87-9; and

WHEREAS, the Council of The City of San Diego, acting on the conducting authority, held a noticed a public hearing on May 9, 1988, on the proposed annexation; NOW, THEREFORE,


