

RESOLUTION NUMBER R-270938

ADOPTED ON MAY 9, 1988

WHEREAS, on January 7, 1988, the Committee '95 of the San Diego-Imperial Area Assembly of Alcoholics Anonymous submitted a bid to its New York headquarters to host the 1995 International Convention of Alcoholics Anonymous in San Diego; and

WHEREAS, the bid was prepared with the assistance of the San Diego Convention and Visitors Bureau (CONVIS), the San Diego Padres, City staff, and the Metropolitan Transit Development Board (MTDB); and

WHEREAS, the convention will run from June 29 to July 2, 1995 and 60,000 delegates are estimated to attend with meetings to be held at 3-6 locations throughout the City over the four-day period, including the San Diego Jack Murphy Stadium; and

WHEREAS, to ease in the transport of delegates between meeting sites, the Committee '95 is proposing that a shuttle service be provided through a contract with the Conference and Meeting Assistance Corporation, for an estimated cost of \$565,750; and

WHEREAS, the Committee '95 is requesting that The City of San Diego provide \$150,000, in conjunction with a similar sum to be provided by tourism industry towards the cost of the shuttle service as an inducement for Alcoholics Anonymous to hold the convention in San Diego; and


