RESOLUTION NUMBER R- 270941

ADOPTED ON MAY 9 1988

WHEREAS, AB 4678, introduced by Assemblyman Peter Chacon, would change the initiative process by requiring a city or county to order an Environmental Impact Report (EIR) on an ordinance approved by the electorate if it is a "project" under the California Environment Quality Act (CEQA); and

WHEREAS, AB 4678, as amended April 4, 1988, contains numerous ambiguities and raises many questions about its requirements; and

WHEREAS, AB 4678 treats those ordinances that are "projects" under CEQA in a dissimilar fashion from those that are not; and

WHEREAS, AB 4678 changes the effective date of a voter-approved measure from ten days after approval to the filing date of an EIR or a negative declaration; and


WHEREAS, AB 4678 places responsibilities on local government which offer numerous opportunities for litigation against local government by proponents and opponents of a proposed measure; and

WHEREAS, AB 4678 does not appropriate state funds for the costs of processing and preparing the review; and

WHEREAS, the background and discussion of this measure is contained in IRD Report No. 88-11, dated April 18, 1988, and was presented to the Rules Committee on May 20, 1988, said Committee approving the recommendation therein unanimously to oppose AB 4678 (Chacon); NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council, for and on behalf of said City, hereby declares its opposition to AB 4678 (Chacon).
