RESOLUTION NUMBER R- 270942

ADOPTED ON MAY 9 1988

WHEREAS, the June 1988 State Primary Election Ballot includes twelve statewide propositions; and

WHEREAS, said statewide propositions are numbered consecutively as Propositions 66 through 77; and

WHEREAS, the City Council has taken a position of support on Propositions 70 and 71 and has actively supported SB 140 (Deddeh) or Proposition 74 by prior Council action; and

WHEREAS, the City Council has previously adopted a position in opposition to a proposition nearly identical to Proposition 69; and

WHEREAS, summaries and recommendations for each of the remaining propositions have been provided by the Intergovernmental Relations Department in its IRD Report No. 88-9, dated April 14, 1988; and

WHEREAS, the Rules Committee now forwards the matter to the City Council with a recommendation that the City oppose Proposition 69 and support Propositions 70, 71 and 74 as summarized in IRD Report No. 88-9; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the Rules Committee recommendations in respect to Propositions 69, 70, 71 and 74 on the June 1988 State Primary Election Ballot,

as summarized in IRD Report No. 88-9, dated April 14, 1988, be
