WHEREAS, on February 25, 1988, the Planning Commission conducted a public hearing for the purpose of considering an amendment to the Otay Mesa Community Plan and Progress Guide and General Plan; and

WHEREAS, Environmental Development, Inc., has requested an amendment to the Otay Mesa Community Plan to change the land use designation on a 32 acre property parcel from very low density residential to commercial; and

WHEREAS, the proposed amendment was processed in compliance with Council Policy 600-35, Processing of Community Plan Amendments; and Council Policy 600-7, General Plan Amendment Procedure; and

WHEREAS, the City Council has considered all maps, exhibits and written documents relative to this proposal, and has considered the oral testimony given at the public hearing; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that it hereby approves the proposed Gateway Fair amendment to the Otay Mesa Community Plan.

BE IT FURTHER RESOLVED, that the City Council hereby approves the proposed amendment to the Progress Guide and General Plan.
