BE IT RESOLVED, by the Council of the City of San Diego that the plans and specifications for the furnishing of all labor, material, tools, equipment, transportation and other expense necessary or incidental for CONSTRUCTION OF ALAMO DRIVE STORM DRAIN, San Diego, California, filed in the office of the City Clerk of the City of San Diego, California, on MAY 16 1988, and bearing official Document No. W.O. 129078, be and the same are hereby approved.

BE IT FURTHER RESOLVED, that the Purchasing Agent of the City of San Diego be, and he is hereby authorized and directed to proceed to publish in accordance with law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for CONSTRUCTION OF ALAMO DRIVE STORM DRAIN.

BE IT FURTHER RESOLVED, that the City Manager and the City Auditor and Comptroller are directed and they are hereby authorized to add CIP No. 11-267 CONSTRUCTION OF ALAMO DRIVE STORM DRAIN as CIP Project to the Fiscal Year 1988 Capital Improvement Program.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer \$78,000 from the Gas Tax Street Improvement Fund 302191 to CIP No. 11-267 CONSTRUCTION OF ALAMO DRIVE STORM DRAIN.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$78,000 from CIP No. 11-267 CONSTRUCTION OF ALAMO DRIVE STORM DRAIN is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
