A RESOLUTION HONORING THE PROPOSITION 13 DECADE - THE ORIGINAL "HOMEOWNER BILL OF RIGHTS"

WHEREAS, Proposition 13 was passed in 1978 by nearly two-thirds of California voters, thereby protecting property owners from runaway taxation; and

WHEREAS, Proposition 13 thus made it possible for senior citizens, those on a fixed income and homeowners in general to keep from losing their homes when unpredictably high and ever increasing property taxes were forcing them out; and

WHEREAS, Proposition 13 protected everyone who owned or purchased property from unreasonable taxation by limiting taxes to 1% of the market value at time of purchase, and kept tax increases to within 2% per year thereafter; and

WHEREAS, Proposition 13 restricted state, county and local governments and entities from raising any tax without first putting such tax increases to a vote of the people; and

WHEREAS, Proposition 13 has saved the taxpayers of California more than \$100 billion over the last ten years; and

WHEREAS, the late Howard Jarvis, co-author of Proposition 13 and author of other unprecedented tax fighting initiatives, worked tirelessly on behalf of citizen's rights, not only in California but throughout the nation; and

WHEREAS, Paul Gann is the co-author of Proposition 13 and author of legislation that has strengthened California's justice system and other legislation that established guidelines to control government spending and encourage citizens to demand accountability from elected officials; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council hereby honors the achievements of Howard Jarvis and Paul Gann and commends the authors of Proposition 13 and their respective organizations, the California Tax Reduction Movement and People's Advocate, for the tremendous benefits that they have bestowed upon the people of California over the past ten years.
