Nancy Lovell	General Services	\$500.00	Ms. Lovell is a Payroll Clerk with the Streets Division. She suggested establishing a computer program to handle service requests for the Street and Refuse Divisions. Although savings are difficult to identify, this was considered to be a significant operational improvement.
Robert Hauptman	Engineering & Development	\$160.00	Mr. Hauptman is a Refrigeration Mechanic with the Buildings Division of General Services. He suggested improving the reliability of air conditioning for the Communications area in the City Operations Building. Although savings are difficult to identify, this was considered to be a significant operational improvement.
Ida Cunradi	Police	\$114.48	Ms. Cunradi is an Intermediate Typist in the Records Division. She suggested the use of 8½" x 11" computer paper, instead of 14" x 12", whenever possible. This has saved the City \$381.60 in materials. This is her full award.
