WHEREAS, over the years, these auctions have been held at a number of sites including San Diego State University, San Diego Jack Murphy Stadium, Golden Hall, and most recently, Al Bahr Shrine; and

WHEREAS, with this action, the City Manager will be authorized to execute agreements, as needed over the next ten years, to hold police auctions at Vacation Village and/or the San Diego Convention and Performing Arts Center; and

WHEREAS, this action would also authorize the City Manager to enter into agreements with other unnamed places should an alternate place be required; and

WHEREAS, lease costs would be paid from the auction receipts (Revenue Account 78510); NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager is authorized to enter into agreements with Vacation Village and/or San Diego Convention and Performing Arts Center for the lease of space for Police Property Auctions during the period 1988 through calendar year 1998.

BE IT FURTHER RESOLVED, that the City Manager is authorized to enter into agreements for the use of other properties for Police Property Auctions should alternate sites be required during said period.

BE IT FURTHER RESOLVED, that any agreements for such space shall be subject to prior review and approval as to form and legality by the City Attorney's office.

BE IT FURTHER RESOLVED, that the payment for such space shall be made solely and exclusively from auction receipts, Fund 100, Revenue Account 78510, during said ten-year period.
